- 5. Pre-bid meeting shall be held at Duhabi, Municipality, Duhabi, sunsari at 2078-05-27, on 11:00 AM
- 6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp or before 12:00 hours on 2078-06-17.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2078-06-17. At the office of Duhabi, Municipality, Office of the Municipal Executive, Duhabi, sunsari Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs.416,000.00 (Four hundred Sexteen thousand) which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days)
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
